## Background

Angela reviewed the Committee Roles & Responsibilities, which are:

- Represent your organization/agency in the update of the TSP
- Share project information with your network
- Guide nontechnical elements of the planning process
- Help review goals, identify needs, review proposed projects and policies
- Participate in four PAC meetings

## **Goals and Objectives**

Reviewed the draft goals and supporting objectives at a high level and discussed them as a group. Discussion points summarized below.

#### Safety and Resilience

- Safer multimodal facilities
- Evacuations: Focus on Tsunamis in past, include other event types like fire (heed warning/learn from California fires)
- Suggest identifying locations with mode conflicts and high crash locations
- Include a variety of climate change scenarios
- Add Fraser Road in documentation to support grant funding
- Reduce non-residence vehicles on the road to improve safety
  - Day trippers are reliant on their cars
  - Safety issues seem to be caused by visitors
  - Reduce reliance on cars for shorter trips once they're here
  - Trolly?
- Outreach
  - Consider multiple channels for outreach, not just Facebook.
  - Use community pages to push out message

#### Mobility and Connectivity

- Active transportation
- Shuttle system
- Need backbone infrastructure to improve parallel routes to US 101 for non-auto (and auto)
- Create awareness and education about available transportation modes
- Have one place folks can go for information on multimodal transportation resources/maps. Being more attractive to choice riders better frequency, more options
- Electric vehicle infrastructure and micromobility
- Should we consider more than just efficient movement? Equitable/accessible
- Language accessibility
- Non-motorized connectivity



#### Land Use and Sustainability

- Seems like an opportunity to align with State's greenhouse gas reduction goals
- Making choices to support compact growth
- Be comprehensive in review of what we are protecting / environmental impact
- EV infrastructure
- Appreciates the examples listed in the objectives
- Every Mile Counts Workplan, which implements the 2050 vision for GHG emission reductions
- Consider the feasibility of providing multi-modal transportation options when assessing comprehensive plan and zoning code changes

#### **Collaboration and Coordination**

- Comprehensive list of all the potential partners make sure they're mentioned in the plan to help with grants
- Focus goal and verbs to emphasize and capitalize on pursuing and prioritizing more proactive language

#### Strategic Investment

- Wondering if we want to focus on also sustainable sources of revenue (not just a sustainable system).
- Sustainable funding is hugely important now given the elimination of federal funding.

#### Community and Economic Vitality

- Confused with the bullets. Some overlap with the other goals. Limit air pollution fits multiple places...
- The focus on supporting desired development...struggled with this goal a bit.
- Need to clean this one up and reduce overlap. Focus more on community.
- Looking for new ways to start businesses. Have one uber driver in whole county. In the busy season, an uber driver would make lots of money traveling between communities. Keeps cars of the road, parking spaces open. Is this the place for that? Maybe that's a TLT grant. More visitor related but locals would take advantage too.
- Extreme weather events
- Can we elevate transit and multimodal to more than just listed in objectives?
